REMEMBER...

DID YOU KNOW?

The most common types of accident involve:

- someone falling from height
- people falling on the flat – tripping
- falls of material onto people
- manual handling
- use of plant and machinery

In the waste recycling industry alone, some of the most serious injuries and fatalities occur after:

- falling from a vehicle
- falling from height
- being struck by a vehicle
- crush injury



SITE RULES



- ▲ You must follow site instructions
- ▲ You must obey the banks person when reversing or when told to do so
- ▲ Safety is a legal requirement
- ▲ You are as much responsible for your own safety as we are
- ▲ You must report all incidents and unsafe situations to a Lift and Shift Yard Operative or Weighbridge Desk Attendant
- ▲ There is a safe way to do EVERY JOB
- ▲ You should not take risks if you are unsure
- ▲ YOU MAY BE REMOVED FROM SITE IF YOU DO NOT FOLLOW THESE RULES
- ▲ Wait to be seen by other drivers of machines and vehicles

To work safely on site, everyone including users and visitors must obey the site rules

If you break the rules you may not be allowed on site

General Site Safety Rules

16. All Lift and Shift Staff shall undergo induction training
17. All persons shall be given a copy of these site rules
18. Appropriate Personal Protective Equipment (PPE) shall be worn at all times
19. Every accident and near miss event shall be reported to Lift and Shift
20. Any person found to be interfering with or misusing fixtures, fittings or equipment shall be removed from site
21. SMOKING not permitted on site outside designated areas. From 1st June 2007 there will be a full smoking ban on site in line with the new legislation
22. VEHICLE DRIVERS must report to the weighbridge office after being directed into the site premises by an official Lift and Shift personnel
23. VEHICLE DRIVERS must not reverse unless being instructed to do so by a Banks person
24. VEHICLE DRIVERS must wear a safety helmet at all times when at risk.
25. Safety Signs and notices must be followed
26. All visiting vehicles must turn on hazard warning lights, beacons and headlamps

General Site Safety Rules

9. When in the yard, be vigilante of moving vehicles and plant machinery and wear high-visibility clothing and hard hat
10. Gloves and Goggles must be worn if there is a risk to health and safety
11. Permission must be obtained from Lift and Shift prior to any photography or video filming on site
12. Mobile Phones, Transistor radios or personal stereo's / music devices must not be used on site unless used in the Staff Rest Room.
13. All personnel, for their own safety and that of others are required to fully comply with their own employer's statement of safe working method.
14. Site Fire and Emergency alarms, equipment and instructions are designed to protect life. They must be followed

Personal Safety Rules

15. All persons are required to wear Safety Helmet and Safety Footwear. High visibility vests are required in vehicle movement areas

Personal Safety Rules

1. Any mechanical plant or equipment found to be defective must not be used and must be reported to the site Operations Manager.
2. Ladders are only to be used as work platforms for tasks of short duration and only if no alternative means of access is readily available. Ladders must always be secured to a structure or securely footed by another person whilst in use.
3. Open manholes must be guarded and cordoned off. The Operations Manager must be informed of open or raised chambers.
4. Food and Drink can only be consumed in the designated areas
5. ANY PERSON which is believed to be under the influence of drugs or alcohol will not be allowed on site
6. No person shall indulge in fighting, horseplay or practical jokes within the site.
7. Machinery must only be operated by the authorised person of that machinery and with permission from the Operations Manager
